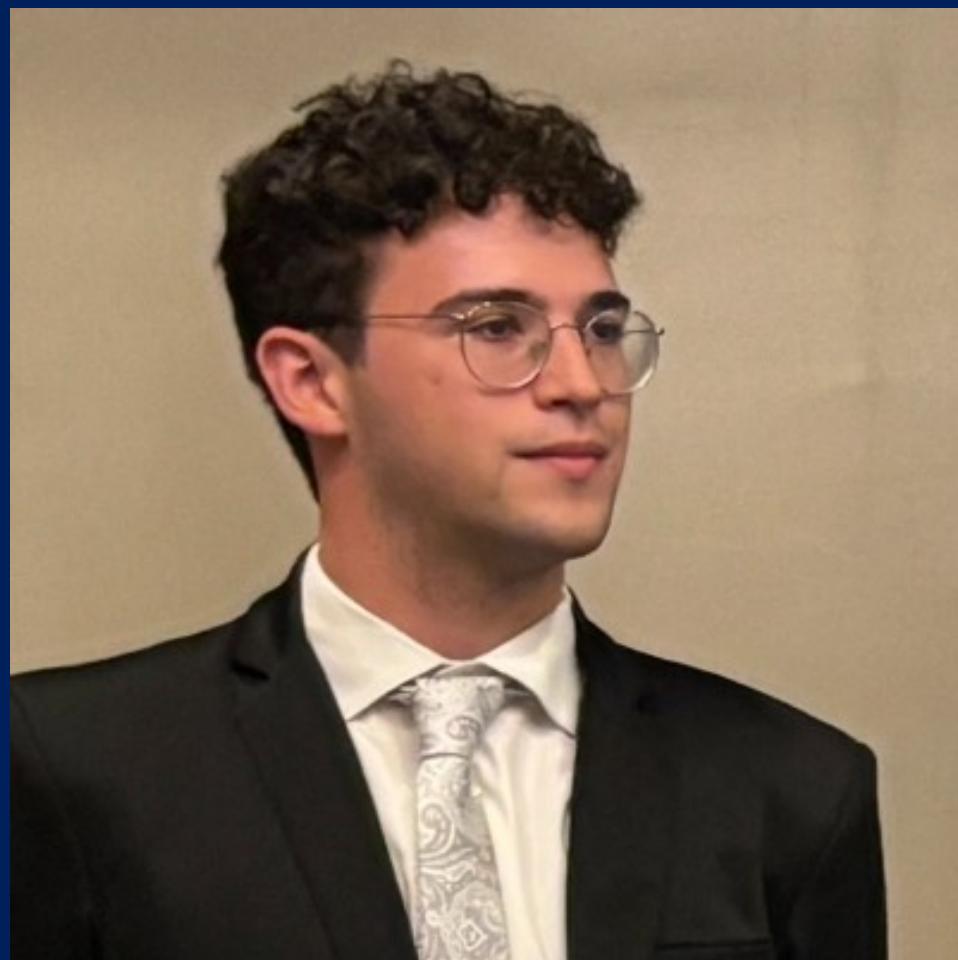

# CAUSE
